



**Program Rules for OANDA Prop Trader Challenges**

(15 July 2024)

There are currently eight Challenge plans available. The Challenge fee and virtual funding level for each are listed below.

<b>Profit target</b>	<b>8%</b>	<b>5%</b>	<ul style="list-style-type: none"> <li>The user passes the Challenge Phase as soon as the respective profit target is reached, provided they have also reached minimum trading days required, and have not violated any other conditions stated here or in the Terms and Conditions.</li> <li>Upon passing Phase one, the trading account used for that Phase is locked. The user is issued a new trading account for Phase two.</li> </ul>
<b>Daily loss limit</b>	<b>5%</b>		<ul style="list-style-type: none"> <li>Violating this limit is a hard breach, meaning loss of Challenge account access.</li> <li>The daily loss limit is the maximum amount (measured in account equity) that the account can lose on any given day. The daily loss limit is set using the previous day's end-of-day equity at 17:00 EST. The daily loss limit increases or decreases with any notional increase or decrease of the account equity.</li> </ul>
<b>Daily max profit limit (Consistency rule)</b>	<b>5%</b>	<b>2%</b>	<ul style="list-style-type: none"> <li>Upon reaching this limit, all open positions will be closed and trading will be disabled until the following day</li> </ul>
<b>Maximum drawdown limit</b>	<b>10% (trailing - hard breach)</b>		<ul style="list-style-type: none"> <li>Violating this limit is a hard breach, meaning loss of Challenge account access.</li> <li>This is the limit on the maximum loss a user can sustain in the lifetime value of their Challenge account in each Phase.</li> <li>The loss limit is calculated versus the maximum value of the account over time. The limit is a percentage of the user's starting account value.</li> <li>This limit is a "trailing" limit, meaning it is calculated versus a high water mark which increases as the value of the account balance increases. However, the breach level is capped at the initial funding amount of the account.</li> </ul>
<b>Max leverage</b>	<b>Up to 100:1 for FX Up to 50:1 for Metals, Indices, and Commodities</b>		<ul style="list-style-type: none"> <li>Leverage shown here is the maximum available on any instrument.</li> <li>Positions will be assigned to a tiered margin structure depending on instrument and size of position converted to USD amount</li> </ul>

<b>Retry discount</b>	<b>20%</b>		<ul style="list-style-type: none"> <li>Users who attempt a Challenge and do not pass will be eligible for a 20% discount on the fee paid to retry the same Challenge</li> </ul>
<b>Min trade size</b>	<b>0.1 lot or 1 CFD index</b>		<ul style="list-style-type: none"> <li>One mini lot, or one index</li> <li>See the following table in this document for details per instrument</li> </ul>
<b>Maximum time</b>	<b>120 calendar days</b>	<b>120 calendar days</b>	<ul style="list-style-type: none"> <li>This is the maximum number of days from the date of their first trade a user has to complete each Phase of the Challenge.</li> <li>Given there are two Phases, this means the maximum number of days a user can use to pass both Phases is 240 days.</li> </ul>
<b>Inactivity time</b>	<b>20 calendar days</b>		<ul style="list-style-type: none"> <li>This is the maximum number of consecutive days a user can be inactive (not place an opening or closing trade) and maintain access to the Challenge account.</li> <li>The period starts from the date of the purchase of a challenge and then restarts on any date of trading activity.</li> <li>Inactivity over 20 calendar days is a hard breach: users who are inactive (no trades placed) for 20 consecutive days lose Challenge account access, and the account is closed.</li> </ul>
<b>News Trading</b>	<b>Restricted</b>		<ul style="list-style-type: none"> <li>Participants should avoid executing any new trades or closing existing trades within a 6-minute window: 3 minutes before and 3 minutes after the release of major news announcements. It's important to note that executing a trade refers to either opening or closing trades from both pending orders or market orders and EAs (Expert Advisors).</li> <li>New positions opened during the 6 minute window will be automatically closed.</li> <li>News trading is a Forbidden Trading Practice as per our Terms and Conditions (available <a href="#">here</a>). Engaging in news trading can lead to profits realized from such trades being removed from the account, and / or termination of account access.</li> <li>Reference list of major (high impact) economic events can be located in the Dashboard - Economic Calendar</li> </ul>

<b>Holding Positions during News</b>	<b>Allowed</b>	<ul style="list-style-type: none"> <li>Trading strategies must not violate the rules described in Rules of Trading and Forbidden Trading Practices as found in the <a href="#">Terms and Conditions</a></li> </ul>
<b>Copy Trading</b>	<b>Partly Allowed</b>	<ul style="list-style-type: none"> <li>Using OANDA Prop Trade Account as Master account where trades can be copied from is allowed.</li> <li>Copy trading into OANDA Prop Trader Account from external accounts (including other OANDA Prop Trader accounts) would be considered a violation of the trading rules and may result in the trading account being breached.</li> </ul>
<b>Flatten on Friday?</b>	<b>Not required</b>	<ul style="list-style-type: none"> <li>Users are not required to flatten/close all open positions each weekend.</li> </ul>
<b>StopLoss required</b>	<b>Not required</b>	<ul style="list-style-type: none"> <li>Users are not required to place StopLoss orders on all positions.</li> </ul>
<b>Refund of Challenge Fee</b>	<b>Available on first profit share payout</b>	<ul style="list-style-type: none"> <li>Users who successfully pass Phase 2 of the challenge and become Signal Providers are eligible for a refund of the fee they paid for the most recent challenge they completed (and only this fee). The refund will be paid with (and not before) the payout of the first profit share according to the payout rules specified for Signal Providers. Signal Providers who do not generate a profit share payout will not receive a refund.</li> </ul>

### Tiered margins

The margin trading available makes use of a tiered margin structure. In this structure, larger positions are subject to higher incremental margin rates.

For example, for USDJPY the margin rates are:

Tier	Net open position (USD)	Margin
1	<0.5 mil	1%
2	0.5 - 2 mil	2%
3	2 - 5 mil	5%
4	5 - 10 mil	10%
5	> 10 mil	20%

A position size of 5 mil (50 lots) in USDJPY would have a margin requirement of **USD 185,000**  
 This is calculated as: (units in tier one x tier one margin rate) + (Units in tier two x tier two margin rate) + (Units at tier three x tier three margin rate).
