

**OANDA PROP TRADER - \$10,000 GIVEAWAY SWEEPSTAKES**

<b>Eligibility</b>	<b>Age</b>	Must be 18 or older. The Sweepstakes winners will be required to provide proof of name, age and address.
	<b>Residency</b>	Must be a resident of a country listed on Annex A.
	<b>SSN/TIN</b>	Must have a valid tax identification number and proof of residency.
	<b>Restricted Persons</b>	Employees, agents, directors or officers of OANDA, or any affiliate of OANDA, including members of their immediate family (i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren and, even if unrelated, those living in the same household) are not eligible to participate in the Sweepstakes.

Review the “Terms and Conditions” and click the “Accept” button;</li> <li>4. Click the “Submit” button at the bottom of the registration form;</li> </ol> Upon completing the above steps 1-4 you will receive one entry into the Sweepstakes.	
<b>Entry Limits</b>	One entry per household during the Promotion Period. In the event of multiple entries being received from the same household only the first entry will be accepted.
