

**OANDA PROP TRADER - Trading Competition**  
**Terms and Conditions**

These official rules (“**Terms and Conditions**” or “**T&C**”) apply to this Competition (as defined below).

<b>Name of Competition</b>	OANDA Prop Trader Trading Competition (the “ <b>Competition</b> ”)

<b>Registration Period</b>	Begins January 10th, 2025 at 12:00 a.m. EDT, and ends January 23rd, 2025, at 12:00 a.m. EDT (the “ <b>Registration Period</b> ”)	
<b>Competition Period</b>	Begins January 23rd, 2025 at 12:00 a.m. EDT, and ends February 6th 2025, at 12:00 a.m. EDT (the “ <b>Competition Period</b> ”)

<b>Eligibility</b>	<b>Age</b>	Must be 18 or older. The Competition winners will be required to provide proof of name, age, residency and address.
	<b>Residency</b>	Must be a resident of a country listed on <a href="https://proptrader-help.oanda.com/is-the-oanda-prop-trader-program-available-in-my-country">https://proptrader-help.oanda.com/is-the-oanda-prop-trader-program-available-in-my-country</a>
	<b>SSN/TIN</b>	Must have a valid tax identification number and proof of residency.
	<b>Restricted Persons</b>	Employees, agents, directors or officers of OANDA, or any affiliate of OANDA, including members of their immediate family (i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren and, even if unrelated, those living in the same household) are not eligible to participate in the Competitions.
<b>To Enter:</b>	<p>Please complete the following steps during the applicable Registration Period:</p> <ol style="list-style-type: none"> <li>1. Log in to your OANDA Prop Trader account. If you do not have one, create one here: <a href="https://proptrader-dashboard.oanda.com/en/sign-up">https://proptrader-dashboard.oanda.com/en/sign-up</a></li> <li>2. On the User Dashboard, click on Competitions</li> <li>3. Click the “Register” button at the bottom of the Competition you want to enter.</li> <li>4. You will receive an email confirming that you have registered for the trading competition.</li> </ol>	
<b>Entry Limits</b>	One entry per participant during the Registration Period. In the event of multiple entries being received from the same participant, the participant will be disqualified.	
<b>Prizes and Prize Values</b>	A total of three (3) prizes will be awarded as set forth below (see Winners Selection Method) based on leaderboard ranking at the end of the Competition Period (each of the following a “ <b>Prize</b> ” and together “ <b>Prizes</b> ”):

<b>Winners Selection Method</b>	Winners are determined based on the highest return percentage and such ranking will be shown as “% Return” on the leaderboard which is accessible through the participant’s online account. All accounts will start with the same virtual balance and the three (3) participants with the highest return percentage rankings at the end of the Competition Period will be selected as winners of the Prizes (1st, 2nd and 3rd accordingly). The decisions of OANDA are final and binding on all matters relating to this Competition.
